Coca-Cola Two-Year Colleges Scholarship Program

- Annually awards **400 scholarships**, of **\$1,000 and \$2,000**, to students attending two-year higher-education institutions granting terminal degrees.
- Each campus can nominate **one student**.
- **Basic eligibility:** Nominees must have at least a 2.5 GPA, have some community service or be employed part- or full-time, and be enrolled in at least two courses during the upcoming fall term at a two-year institution.
- **Deadline:** Please contact your financial aid office for deadline information.

Undergraduate Transfer Scholarship Program

- Annually awards approximately **50 scholarships** worth **up to \$30,000** to students and recent alumni from accredited community colleges transferring to four-year colleges.
- Each college can nominate **two students or recent alumni**.
- **Basic eligibility:** Nominees must have at least a 3.5 GPA; have sophomore status by December 31, 2007, or have graduated after spring 2003 from an accredited two-year college; and plan to enroll full-time in a four-year college in fall 2008, respectively. The Foundation seeks applicants with academic excellence and unmet financial need, among other criteria.
- **Deadline: Campus deadlines vary.** Contact your faculty representative. Foundation **receipt** deadline is **February 1, 2008**.

Hispanic Scholarship Fund

Community College Transfer Scholarship Program

- Annually awards **200 scholarships** of **\$1,250 and \$2,500** to students transferring from a two-year college to a four-year institution.
- Students applying may be transferring to any U.S. accredited four-year institution in the U.S., Puerto Rico, the U.S. Virgin Islands, and Guam in fall of 2008 or spring of 2009.
- **Basic eligibility:** Applicants must be of Hispanic heritage; be a U.S. citizen or legal permanent resident; be currently enrolled part-time or full-time at a community college; have plans to transfer and enroll full-time at a four-year, U.S.-accredited institution; have a minimum cumulative GPA of 3.00; and apply for federal financial aid using the FAFSA.
- **Deadline:** Apply online at www.hsf.net by March 15, 2008.
